McClure Elementary GOALS

At least 18% of all, Hispanic and Economically Disadvantaged students in grades 3-5 will score proficient/advanced on the ELA PSSA.

At least 16% of grade 3 students will score proficient/advanced on the ELA PSSA.

At least 10% of grade 3-5 students will score proficient/advanced on the Math PSSA.

At least 45% of all students will attend school 95% of days or more.

At least 99% of students will have zero out-of-school suspensions.

SCHOOL/TEACHER RESPONSIBILITIES:

McClure Elementary will:

On a monthly basis, teachers will provide families with an academic calendar, along with games and activities that families can play to review the grade-level skills being covered in class.

K-5 teachers who participate in APTT (Academic Parent Partner Teams) will support families with setting goals and utilize the Report Card conferences to set goals with families regarding grade level goals and provide resources to support those goals.

Provide opportunity to support parents in sign up and use of Parent Portal in conjunction with our FACE representative.

Hold parent-teacher conferences as follows: November 21 – 23, 2022; February 1 - 3, 2023; March 29 – 31, 2023.

Interim reports will be shared as follows: October 12 – 14, 2022; December 21 – 22, 2022; February 27 – March 1, 2023; May 8 – 10, 2023.

Provide parents reasonable access to staff. Staff will be available during Report Card Conferences, via e-mail, scheduled appointments, MTSS conferences, and IEP conferences. Please adhere to the Visitor Policy and appropriate times when making arrangements. Parent Concern Forms can be found in the Main Office; staff will follow up on concerns within 24 hours, unless there are extenuating circumstances.

Visitors are welcome at McClure Elementary. ALL visitors must have photo identification to enter McClure Elementary. Please follow our Visitor Guidelines prior to visiting:

Send a note or call your child's teacher to pre-arrange a time for an appointment when the teacher is not instructing his/her class. If you would like to visit the classroom, 24-hour notice is required. Please contact your child's teacher to make arrangements. All parents and/or visitors must enter through the Marshall Street entrance of the building and report immediately to the Main Office (located on the 2nd floor). You will need to show photo identification and complete the visitor's log.

Appointments with the principal can be made by calling the Main Office 215-400-3870.

Provide parents with opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

McClure Elementary welcomes parents who would like to volunteer; participate in their child's class, and observe classroom activities. If interested in volunteering, please contact your child's teacher and notify the Main Office. McClure's assigned FACE representative will support parents with the process of obtaining clearances. Parents who would like to volunteer on an ongoing basis require appropriate clearances and will be placed by administration. Ongoing volunteers will not be placed in their child's classroom for extended periods to volunteer.

Classroom teachers will also extend invitations to parents and guardians to participate in class projects, presentations and celebrations. In addition, you may visit the classroom/observe in the classroom by following the visitor guidelines outlined above.

PARENT RESPONSIBILITIES:

We, as parents, will:

Monitoring attendance and limiting lateness and early dismissals to emergencies only.

Making sure that homework is completed.

Monitoring and limiting my child's use of electronics, internet and social media.

Families will utilize the resources geared toward achieving grade level goals and comply with the guidelines of the APTT Grant.

Volunteering in the school.

Participating, as appropriate, in decisions relating to my child's education.

Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.

Serving, to the extent possible, on policy advisory groups, such as being the Title I, Part A parent representative on the school's SAC Team.
